



Terms & Conditions

1. "Getaway" service (the "Service") is only applicable to designated 4G/3G postpaid customers of 3HK and is subject to a fixed contract period of 24 months ("Fixed Contract Period"). The following types of services are included within the Fixed Contract Period under the Service:
 - a) Roaming data ("Travel Data") for 80 days
 - (i) Travel Data may be used in designated destinations and on designated networks on any 80 days.
 - (ii) Subsequent usage of Travel Data in designated destinations and on designated networks will be charged at \$25/day.  - (iii) Speed of Travel Data will be adjusted to not higher than 256kbps when usage reaches 500MB in each destination on any day.

 - Inbound calls from all destinations and outbound calls to Hong Kong: Unlimited
 - Outbound calls with the dialing code of [1968] to designated destinations and designated prefixed fixed line or mobile numbers dialing codes: 60 minutes (not applicable to certain destinations or area codes of certain destinations, please refer to 3 Super Talk Excluded Prefixes List). Excess usage or other outbound calls to non-designated destinations and non-designated area codes of certain destinations are subject to the standard service fees of IDD1968 service).  - (ii) You may use roaming voice service under 3 Super Talk via the App through mobile data or WiFi connection irrespective of your physical location whether local or overseas. 3 Super Talk does not include service charges for local and roaming mobile data, Wi-Fi data connectivity, IDD call charges or any other charges that may be incurred for using this service.
