



\$66 Google Play 消費回贈優惠之條款及細則

Terms and conditions-\$66 Google Play Spending Rebate Offer

1. 推廣期由即日起至 2018 年 5 月 31 日止、2018 年 6 月 14 日至 2018 年 8 月 30 日、2018 年 9 月 22 日至 2018 年 10 月 31 日及 2018 年 11 月 24 日至 2019 年 1 月 6 日止。The promotion period is from now until 31 May 2018, from 14 June until 30 August 2018, from 22 September until 31 October 2018, from 24 November 2018 until 6 January 2019.
2. 只適用於 3 香港流動通訊服務月費客戶(「合資格客戶」)於推廣期內首次成功以 3 香港賬單付款服務(「Bill-to-3」)於 Google Play 購買任何產品或服務(「交易」)。交易款項須於 3 香港就該交易發出賬單後全數繳付。Only applicable to 3HK customers of monthly postpaid mobile service (“Eligible Customers”) having successfully settled payment on any purchase of product or service on Google Play (“Transaction”) through 3HK Billing service (“Bill-to-3”) for the first time within the promotion period. Transaction amount shall be settled in full upon issuance of the 3HK bill for the Transaction.
