



## Terms and Conditions:

1. Please read the below terms and conditions on ticketing and admission applicable to the VIVELAND x E.R Studio VR Experience Centre (“the Centre”). 2. Tickets sold through any channel are non-refundable, non-exchangeable and cannot be re-sold, and can be used for admission of one person in one single session only.
3. Tickets are valid only on the specified date or during the specified period printed on the tickets
4. Children tickets apply for children aged 6-11; Special Discount tickets apply for people with disabilities and full-time students. Free entries apply for children aged 5 or below. Children under 100 cm in height are not allowed to experience the contents of the multiplayer shooting area.
5. Please present valid proof of age or identity when using Children tickets or Special Discount tickets before entering the centre \*.
6. Children aged 11 or below must be accompanied by a person aged 15 or above. Children aged 5 or below shall not use any VR equipment.
7. Consent and assistance of staff to put on VR equipment is required for VR experience.
8. In case of any discomfort during VR experience, please inform our staff immediately.

For safety reasons, certain facilities are not suited to pregnant women, or those who are suffering from chronic illness, mental illness, epilepsy, motion sickness, claustrophobia, heart disease, high blood pressure, other eye diseases or abnormal vision, physical discomfort, had any form of recent surgery, or under the influence of medications or alcohol. Please refer to the detailed instructions on the site and adhere to the instructions of our staff.
10. Guests shall exercise their own judgment on whether they are physically fit for joining the activities. The Centre shall not be held responsible for any person’s physical conditions.
