

Terms & Conditions

- 1. 24Reader (3Basic Channels) (this "Service") is an e-book service. Upon successful application, a customer may make use of this Service by searching for and downloading the software application (Apps) of 24Reader (3Basic Channels) (the "24Reader (3Basic Channels) Apps") from Google Play or App Store. Standard monthly fee is HK\$38.
- 2. Subscriber who subscribes free trial for the 24Reader (3Basic Channels) Value-Added Service can enjoy a 2-month free trial. The free offer is only applicable to first-time subscribers. This free trial promotion cannot be used in conjunction with any other promotional offers. Upon expiry of the free trial period, a standard monthly fee of HK\$38 will be charged automatically to the relevant registered customer account on a monthly basis. To cancel subscription, please call 3 Customer Services Hotline at least one day prior to the end day of the promotion period. This offer is subject to the final decision of HTCL. HTCL reserves the right to change the terms and conditions of the above offer at any time without prior notice.
- 3. If a customer is to subscribe for this Service as an engagement for its value-added service contract, or as the designated value-added service commitment when engaging for a fixed contract term for its newly subscribed mobile devices, and to sign up for a designated contractual term, and/or to subscribe for a designated monthly plan for mobile devices (if applicable), then the customer will be entitled to subscribe for this Service at preferential service feesnamely HK\$36 per month. For the avoidance of doubt, immediately after the completion of the designated contractual term for this Service, this Service shall automatically be charged at the standard service fees, namely HK\$38 per month (save and except that HTCL has been notified by the customer of its intention to terminate this Service).
- 4. If the customer is to subscribe for this Service as the designated value-added service commitment when engaging for a fixed contract term for its newly subscribed mobile devices, then any termination of the monthly plan for the mobile devices for whatever reasons shall also lead to the automatic termination of this Service accordingly.
- 5. Once the customer has confirmed its subscription for this Service as an engagement for a value added service contract on fixed contract term and the customer is to terminate this Service before the expiry of the applicable contractual term, then the customer shall have to pay to HTCL the liquidated damages which amount to the aggregate of the monthly service fees payable for the remaining contractual term.
- 6. The 24Reader (3Basic Channels) as included in and applicable to this Service are channels for fixed monthly service fees. Even if the customer is to actually use this Service for less than a month, the applicable monthly service fee shall still be payable by the customer in full but not refundable at all on any pro-rata basis. Once the customer has confirmed its subscription for this Service, the service fee shall automatically be chargeable on a monthly basis.
- 7. This Service shall only be applicable to the 3G or 4G LTE mobile customers of HTCL but not any prepaid SIM card customers.





- 8. This Service shall only be applicable to the operation system of Android 2.2 or above and ios5.0 or the above (supporting the resolution of 1920X1080, 1280x720 and 1024x768).
- 9. When the customer is to download the 24Reader (3Basic Channels) Apps and/or use this Service through the data network, the relevant data transfer fee shall additionally be charged by HTCL. If the customer is to download the 24Reader (3Basic Channels) Apps and/or use this Service overseas, it may be required to pay separately the relevant data roaming fee. The local data transfer fee shall be waived with downloading the file of e-book of this service.
- 10. If, at the time of or after subscribing for this Service through HTCL, the customer is also to apply or subscribe for this Service through any other way for whatever reasons and results in any extra fee or loss therefrom, HTCL shall not in any event be responsible for any such extra fee or loss.
- 11. To terminate this Service, customer must notify HTCL by calling the 3 customer hotline 1033. Monthly fee for this Service is chargeable in advance. This Service shall forthwith be terminated as from HTCL's receipt of customer's termination notice, The service fee payable for such relevant month shall not be refundable at all on any pro-rata basis.
- 12. Any subsequent or renewal subscription for this Service by the customer after any prior termination of this Service for whatever reasons shall be regarded as a new subscription for this Service. The customer shall have to call directly to the 3 customer hotline 1033 for completing the subscription procedure, and the contractual term and billing for this Service shall commence accordingly as from the completion of the relevant subscription procedure by the customer.
- 13. Once the customer has confirmed its subscription for this Service as an engagement for a value added service contract, this Service shall not be exchanged for another value-added service package of the same or different value during the relevant contractual term.
- 14. The content of this Service shall be provided by a third party supplier, namely Guangbo Media, Ltd (光波文化 總公司). The content of this Service may change without any prior notice. HTCL shall not be responsible for any liability incurred from or in connection with the content, the downloading of the 24Reader (3Basic Channels) Apps and/or use of this Service (including but not limited to the accuracy of the information provided by the third party supplier, and any fees, expenses, losses and damages incurred from or caused by the downloading of the 24Reader (3Basic Channels) Apps and/or use of this Service by the customer or any other persons). HTCL shall have the final discretion as to any dispute in all respects in relation to this Service.

Once the customer has successfully subscribed for this Service, it shall be subject to the terms and conditions relating to the service as contained herein, and shall also be subject to the 3G and 4G LTE Service Terms and Conditions of HTCL which can be found on HTCL's website http://www.three.com.hk/ <<Terms & Policies>> 3G and 4G LTE Service Terms and Conditions.
