



## Terms & Conditions

1. These are (i) photo printing service ("Photo Printing Service") and (ii) photo book printing service ("Photo Book Printing Service"). Photo Printing Service and Photo Book Printing Service are collectively referred to as the "Service". Upon successful application, customer may use:
  1. Photo Printing Service by downloading the software application (Apps) of Shot'n Print (the "Shot'n Print Apps") from Google Play or App Store, or use the Service via Shot'n Print website; and
  2. Photo Book Printing Service by downloading the Shot'n Print Apps from App Store (not via Google Play).
2. Photo Printing Service:
  1. Subscription of the Photo Printing Service at standard monthly service fee at \$24, or as the designated value-added service commitment when engaging for a fixed contract term for newly subscribed for or upgrade mobile devices at \$19 monthly package, subscribers can print up to 30pcs of 2R/3R/4R/4S photo, OR 2 pcs of Panorama photo OR 1pc of 8R/12R photo per month via specific application;
  2. Subscription of the Photo Printing Service at standard monthly service fee at \$36, subscribers can print up to 60 pcs of 2R/3R/4R/4S photo, OR 4 pcs of Panorama photo OR 2pcs of 8R/12R photo per month;
  3. Subscription for the Photo Printing Service as the designated value-added service commitment when engaging for a fixed contract term for newly subscribed for or upgrading of mobile devices at \$39 monthly package on or before 19 June 2018, subscribers can print up to 30 pcs of Marker Photo (3.5"x4") per month.
  4. Subscription for the Photo Printing Service as the designated value-added service commitment when engaging for a fixed contract term for newly subscribed for or upgrading of mobile devices at \$39 monthly package on or after 20 June 2018, subscribers can print up to 50pcs of 2R/3R/4R/4S photos, OR 20 pcs of Marker Photo (3.5"x4") per month.
  5. Each of the monthly packages is entitled to local postal delivery once. Subscribers can subscribe for more than one of the monthly service packages at the time of subscription, i.e. any one of the \$19, \$24, \$36 or \$39 monthly packages mentioned above irrespective of whether subscription of the Service is at standard service fee or as a designated value-added service commitment when engaging for a fixed contract term for newly subscribed for or upgrade of mobile devices.
  6. Subscriber who subscribes free trial for the Photo Printing Service can enjoy a 2-month free trial. The free offer is only applicable to first-time subscribers. This free trial promotion cannot

be used in conjunction with any other promotional offers. Upon expiry of the free trial period, the Photo Printing Service will continue to be provided at a monthly fee of \$24. To cancel subscription, please call Customer Services Hotline 1033 at least seven days prior to the end day expiry of the free trial period. This offer is subject to the final decision of HTCL. HTCL reserves the right to change the terms and conditions of the above offer at any time without prior notice.

7. Customer may subscribe for standalone Photo Printing Service (at \$24 or \$36 per month) or subscribe for Photo Printing Service (at \$19 or \$39 per month) as the designated value-added service commitment when engaging for a fixed contract term for its newly subscribed for or upgrade of mobile devices, and to sign up for a designated contractual term, and/or to subscribe for a designated monthly plan for mobile devices (if applicable). Upon expiry of the designated contractual term of Photo Printing Service, such service will continue to be provided and charged at the standard service fees, namely \$19 or \$39 per month (as the case may be) (save and except that HTCL has been notified by the customer of its intention to terminate the Photo Printing Service).
3. Photo Book Printing Service:
1. Each photo book may upload photos via Shot'n Print Apps to print 48 photos on individual pages plus 1 photo cover (49 pages in total) upon service subscription
  2. Standard fee at \$60 for 1 photo book (49 photos), subscribers can upload photos within 30 days in accordance with paragraph 3.1 above.
  3. Subscription of the Photo Book Printing Service as the designated value-added service commitment when engaging for a fixed contract term for newly subscribed for or upgrade of mobile devices at monthly service fee at \$48, subscribers can print 49 photos for 1 photo book in accordance with paragraph 3.1 above OR 50 pcs of 2R/3R/4R/4S photos per month.
  4. The above Photo Book Printing Service is entitled to local postal delivery. Subscribers can subscribe for more than one of the services at the time of subscription.
  5. Upon expiry of the designated contractual term for the Photo Book Printing Service, such service will continue to be provided and charged at \$48 per month (save and except that HTCL has been notified by the customer of its intention to terminate the Photo Book Printing Service).
4. If the customer is to subscribe for the Service as the designated value-added service commitment when engaging for a fixed contract term for its newly subscribed for or upgrade of mobile devices, then any termination of the monthly plan for the mobile devices for whatever reasons shall also lead to the automatic termination of the Service accordingly.
  5. Fixed monthly service fees is chargeable for the Service. (Except for the Photo Book Printing Service subscribed for on a standalone basis which is charged one-off). Even if the customer is to actually use the Service for less than a month, the applicable monthly service fee shall still be payable by the customer in full but not refundable at all on any pro-rata basis. Once the customer has confirmed its subscription for the Service, the service fee shall automatically be chargeable on a monthly basis.

6. The Service shall only be applicable to the 3G, 4G LTE or 5G mobile customers of HTCL but not any prepaid SIM card customers.
7. The Service shall only be applicable to the operation system of Android 4.0 or above, iOS 7.0 or above.
8. When the customer is to download the Shot'n Print Apps and/or use the Service through the data network, the relevant data transfer fee shall additionally be charged by HTCL. If the customer is to download the Shot'n Print Apps and/or use the Service overseas, it may be required to pay separately the relevant data roaming fee.
9. If, at the time of or after subscribing for the Service through HTCL, the customer is also to apply or subscribe for the Service through any other way for whatever reasons and results in any extra fee or loss therefrom, HTCL shall not in any event be responsible for any such extra fee or loss.
10. To terminate the Service, customer must notify HTCL by calling the 3Customer Services Hotline 1033 not less than 7 days before the then current statement cutoff date of the Service. Termination of the Service shall forthwith become effective as from HTCL's receipt from the customer of the termination notice, or customer can continue to use the Service until the next payment due date of the monthly fee (as the case may be), and the service fee payable for such relevant month shall not be refundable at all on any pro-rata basis.
11. Any subsequent or renewal subscription for the Service by the customer after any prior termination of Service for whatever reasons shall be regarded as a new subscription for such service. The customer shall have to call directly to the 3 customer hotline 1033 for completing the subscription procedure, and the contractual term and billing for the Service shall commence accordingly as from the completion of the relevant subscription procedure by the customer.
12. Once the customer has confirmed subscription for the Service as an engagement for a value added service contract, such service shall not be exchanged for another value-added service package of the same or different value during the relevant contractual term. In addition, once the customer has confirmed subscription for any of the "2R/3R/4R/4S photo, OR Panorama photo OR 8R/12R photo" monthly service plan, such service shall not be exchanged for the "Marker photo (3.5"x4")" monthly service plan, or vice versa.
13. The content of the Service shall be provided by a third party supplier, namely Always Online Technology Limited. The content of the Service may change without any prior notice. HTCL shall not be responsible for any liability incurred from or in connection with the content, the downloading of the Shot'n Print Apps and/or use of the Service (including but not limited to the accuracy of the information provided by the third party supplier, and any fees, expenses, losses and damages incurred from or caused by the downloading of the Shot'n Print Apps and/or use of the Service by the customer or any other persons). HTCL shall have the final discretion as to any dispute in all respects in relation to the Service.
14. Once the customer has successfully subscribed for the Service, it shall be subject to the terms and conditions relating to the service as contained herein, and shall also be subject to the 3G, 4G LTE and 5G Service Terms and Conditions of HTCL which can be found on HTCL's website <http://www.three.com.hk/> > Terms & Policies > 3G, 4G LTE and 5G Service Terms and Conditions. If



there is any conflict between the terms and conditions relating to the Service as contained herein and the 3G, 4G LTE and 5G Service Terms and Conditions of HTCL, the former shall prevail.

15. Should there be any inconsistencies between the Chinese and English versions of these terms and conditions, the English version shall prevail.
