

## VC App Free Local Data Pack - Terms and Conditions -

- Customer who use the VC App is provided by Valuable Capital and the use of VC App Free Local Data Pack is subject to the following terms and conditions.
- VC App Free Local Data Pack ("Service") offers the following service package: Service package: Customer use VC App ("App") at 3HK network and 3HK will waive the related local traffic derived from the use of VC App within the fixed contract period ("Fixed Contract Period"). The Service will be automatically terminated upon expiration of the fixed contract period.
- 3 The above Service Package is applicable to designated 3G, 4G LTE and 5G mobile customers of 3HK.
- 3 Customer will be provided with the service activation date via SMS. This Service is to waive data traffic of utility program service. Customer is required to access the website (<a href="https://hk.vbkr.com/download">https://hk.vbkr.com/download</a>) and download VC App.
- 2. Data usage and related fees incurred under following circumstances is not included in the monthly fee under the Service Package.
  - 4.1 Downloading the App;
  - 4.2 Viewing Youtube videos through the App;
  - 4.3 Advertisements provided by 3rd parties through the App (i.e. DoubleClick, Google common, Google Adsense, Google Analytics, etc);
  - 4.4 Receiving and browsing push notifications from Google and iOS through the App; and
    - 4.5 Using the App feature to load images; and
    - 4.6 Using the App to login non-HK server; and
    - 4.7 Using the App via VPN.
- 3. The Service cannot be changed to any other type of value-added service within the Fixed Contract Period. If customer within the Fixed Contract Period of the Service, (i) terminates this Service; or (ii) terminates the Monthly Plan with 3HK; customer agrees to pay to 3HK an early termination charge equivalent to the monthly fees multiplied by the number of months remaining of the Fixed Contract Period of the Service.
- 4. Customer is subject to the terms and conditions of the Service upon successful activation of the Service, and also the 3G, 4G LTE and 5G Service Terms and Conditions of 3HK (<a href="http://www.three.com.hk/">http://www.three.com.hk/</a>). In case of any conflict between the terms and conditions of the Service as specified herein and the 3G, 4G LTE and 5G Service Terms and Conditions of 3HK, the former will prevail.
- 5. If customer terminates the Service Package or ceases to be a customer of 3HK, the Service account will be terminated automatically.
- 6. 3HK will have the right at any time to amend or cancel the contents, terms and conditions of the above offers without prior notice. 3HK will have the right of final decision in case of any dispute.
- 7. Should there be any inconsistencies between the Chinese and English versions of these terms and conditions, the English version will prevail.
- 8. Terms and Conditions of the Service are governed by the laws of Hong Kong and the customer shall submit to the non-exclusive jurisdiction of Hong Kong courts.
