



3 香港賬單付款服務 (「Bill-to-3」) 消費回贈優惠之條款及細則
Terms and Conditions – 3HK Billing Service 「Bill-to-3」 Spending Rebate Offer

1. 只適用於指定 3 香港流動通訊服務月費客戶(「合資格客戶」)於推廣期內首次成功以 3 香港賬單付款服務(「Bill-to-3」)於 App Store/Apple、Google Play 或 HUAWEI AppGallery 購買任何產品或服務(「交易」)。交易款項須於 3 香港就該交易發出賬單後全數繳付。

Only applicable to selected 3HK customers of monthly post-paid mobile service ("Eligible Customers") having successfully settled payment on any purchase of product or service on App Store/Apple, Google Play or HUAWEI AppGallery ("Transaction") through 3HK Billing service ("Bill-to-3") for the first time within the promotion period. Transaction amount shall be settled in full upon issuance of the 3HK bill for the Transaction.

- 1.1 [適用於 Apple Store/Apple 客戶] 於指定推廣期內，每一合資格 Apple Store/Apple 客戶之首次成功交易可享回贈金額一次(「回贈」)，回贈上限為港幣 33 元。

[Applicable to Apple Store/Apple Customer] Each Eligible App Store/Apple Customer is entitled to a rebate ("Rebate") once from the first successfully completed Transaction within selected promotion period, up to a maximum of HK\$33.

- 1.2 [適用於 Google Play 客戶] 於指定推廣期內，每一合資格 Google Play 客戶於連續 6 個月內成功交易可享回贈金額，每月回贈上限為港幣 6 元(「回贈」)，回贈上限共港幣 36 元。如客戶當月未有透過 Bill-to-3 消費，將不獲當月的回贈。

[Applicable to Google Play Customer] Within selected promotion period, each Eligible Google Play Customer is entitled to a rebate ("Rebate") once per month, capped at HK\$6 each month for 6 months consecutively from successfully completed Transactions, up to a maximum of HK\$36 in total. If customer does not purchase through "Bill-to-3" in the month, the rebate will not be given for the month.

- 1.3 [適用於 Huawei AppGallery 客戶] 於指定推廣期內，每一合資格 HUAWEI AppGallery 客戶之首次成功交易可享回贈金額一次(「回贈」)，回贈上限為港幣 33 元。

[Applicable to Huawei AppGallery Customer] Each Eligible Customer is entitled to a rebate ("Rebate") once from the first successfully completed Transaction within selected promotion period, up to a maximum of HK\$33.

2. 回贈於交易日後 90 天內(「入賬期」)存入相關合資格客戶之 3 香港服務賬戶，可作抵消該賬戶內之任何應繳費用。
The Rebate will be deposited into the relevant Eligible Customer's 3HK service account within 90 days after the transaction date ("Credit Period") which can be used to offset any amount invoiced under the same account.

3. 如合資格客戶之月費計劃或 3 香港服務賬戶於入賬期內因任何原因被終止，回贈將被作廢。3 香港保留於合資格客戶賬戶扣除已存入回贈之權利(如適用)。

The Rebate will be forfeited if the monthly plan or relevant 3HK service account of the Eligible Customer is terminated for whatever reason within the Credit Period and in such event 3HK shall have the right to debit the deposited Rebate from the service account of the Eligible Customer (if applicable).

4. 此優惠不能與其他優惠同時使用。

This offer cannot be used in conjunction with any other promotional offers.

5. 回贈不能轉賬至第三方或兌換現金。

The Rebate is not transferrable to any third party nor exchangeable for cash.
