

## 新機王預訂優惠條款及細則

- 1. 新客/現有客戶("客戶")即日起至2024年9月19日·上台/續約/升級指定5G月費計劃("計劃")並於續約/升級日起計7天內及於2024年9月19日或之前以信用卡繳交 HK\$500 預付金額以享指定新機王預訂優惠("優惠")
  - 保証於機王公開發售日起計7天內取指定型號手機;
  - 電影禮券6張及
  - 以下任何一項:
    - A. HK\$800手機折扣(指定機王系列型號手機);或
    - B. 免費容量升級優惠 (指定型號容量升級由128GB至256GB)

## Terms & Conditions: New Flagship Handset Pre-Order Offer

- 1. New / Existing customers ("Customers") who subscribe/renew/upgrade to the designated 5G monthly plan ("Plan") starting from now till 19 September 2024, and make a prepayment of \$500, within 7 days from the plan renewal/upgraded date and on or before 19 September 2024, by credit card to get the Early Bird Offer ("Offer") on the purchase of designated handset model of New Flagship Handset Series ("Designated Handset"), will enjoy the following:
  - A quarantee to get the designated flagship handset within 7 days from the official launch day;
  - Free 6 Movie Vouchers; AND
  - Either option below:
    - A. \$800 handset discount (applicable to designated flagship handset series); OR
    - B. Free storage upgrade (applicable to designated model storage upgrade from 128GB to 256GB)
- 2. Customers must be committed to at least a 24-month duration contract.
- 3. This offer excludes Home Broadband Service Plan, 5G Broadband, Staff Plan and Secondary SIM of Multi-SIM plan.
- 4. New Customer must sign up the Designated Plan service contract by 19 September 2024 and activate the related account service by 20 October 2024 in order to enjoy the Offer.

- 6. The \$500 prepayment can be used for bill payment only.
- 7. The handset discount and storage upgrade offer is counted based on the suggested retail price.
