


Terms and Conditions of the Link-Up My3 App and MoneyBack App Account Offer:

- 1. This offer is valid till 15 November 2025 ("Promotion Period").
- 2. During the Promotion Period, customers who subscribe to, renew, or upgrade to a designated 5G monthly plan and activate the service on or before the designated date, and successfully link up their MoneyBack App account to 3 Hong Kong mobile number account via My3 App ("3 Hong Kong Platform") within 14 days from the service activation, can enjoy 500 MoneyBack Points.
- 3. Designated service activation dates:
 - New subscription: Must activate the service on or before 15 November 2025
