



## **WORLD PLAN Monthly Plan Terms & Conditions:**

### **1. Subscribe with New Number**

\$198 monthly fee is net monthly fee after deducting the \$180 monthly fee rebate (original monthly fee: \$378). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$268 monthly fee is net monthly fee after deducting the \$110 monthly fee rebate (original monthly fee: \$378). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$338 monthly fee is net monthly fee after deducting the \$40 monthly fee rebate (original monthly fee: \$378). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$368 monthly fee is net monthly fee after deducting the \$60 monthly fee rebate (original monthly fee: \$428). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$458 monthly fee is net monthly fee after deducting the \$80 monthly fee rebate (original monthly fee: \$538). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$728 monthly fee is net monthly fee after deducting the \$100 monthly fee rebate (original monthly fee: \$828). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$958 monthly fee is net monthly fee after deducting the \$140 monthly fee rebate (original monthly fee: \$1098). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

### **2. Port-in**

\$198 monthly fee is net monthly fee after deducting the \$180 monthly fee rebate (original monthly fee: \$378). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan

fee) after the contract expires.

\$268 monthly fee is net monthly fee after deducting the \$110 monthly fee rebate (original monthly fee: \$378). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$338 monthly fee is net monthly fee after deducting the \$40 monthly fee rebate (original monthly fee: \$378). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

\$368 monthly fee is net monthly fee after deducting the \$60 monthly fee rebate (original monthly fee: \$428). Monthly fee rebate will be credited to customer's billing account by instalments during contract period. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

Average monthly fee \$396 is calculated based on the original monthly fee \$538, after deducting basic monthly fee rebate \$80, extra \$83 monthly fee rebate from 7<sup>th</sup> – 23<sup>rd</sup> month and extra \$89 monthly fee rebate in 24<sup>th</sup> month within contract period have been given to the customer. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

Average monthly fee \$645 is calculated based on the original monthly fee \$828, after deducting basic monthly fee rebate \$100, extra \$111 monthly fee rebate from 7<sup>th</sup> – 23<sup>rd</sup> month and extra \$113 monthly fee rebate in 24<sup>th</sup> month within contract period have been given to the customer. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

Average monthly fee \$875 is calculated based on the original monthly fee \$1098, after deducting basic monthly fee rebate \$140, extra \$111 monthly fee rebate from 7<sup>th</sup> – 23<sup>rd</sup> month and extra \$113 monthly fee rebate in 24<sup>th</sup> month within contract period have been given to the customer. Customers will be charged with the original monthly plan fee (or at prevailing plan fee) after the contract expires.

3. World Plan Monthly Plan ("Service") is subject to a 24-month fixed contract period ("Fixed Contract Period") and an administration fee of HK\$28 per month. Admin fee waiver is applied to service subscription during promotion period. If the contract is terminated for any reason before its expiry, the customer must pay an early termination fee equivalent to the monthly service fee multiplied by the number of remaining months in the fixed contract term.
4. Subscribe to designated WORLD PLAN within the promotion period to enjoy bonus roaming voice minutes per month during contract period. Promotion period valid until 31 March 2026.
5. Roaming and IDD services will be activated automatically upon subscription of the Service and cannot be deactivated while the Service is in use. For Roaming & IDD service details please visit: <https://web.three.com.hk/roaming>.
6. The data usage entitlement is applicable to Hong Kong and designated countries/ regions

(designated Network Operators only). 3HK's other designated data roaming services are not applicable to the above. Customer may subscribe for and use other roaming data service plans of 3HK for using such services in non-designated countries/ regions at the rate charged under such service plans, otherwise standard roaming charge will apply. 7. An SMS alert will be sent to customer when data usage nearly reaches the limit of subscribed data services or used up entitled data respectively. When the monthly data usage reaches the plan entitlement, Hong Kong local data service can continue with a maximum local data access speed of 1Mbps till end of current bill cycle. Roaming data service in designated countries or regions will be suspended until the end of the billing cycle. Customers may reply to the SMS to purchase additional roaming data as needed.
8. The roaming voice call service included in this plan is only applicable during the contract period, and only for receiving calls, calling to Hong Kong, or making local calls in designated countries or regions. This service does not include roaming voice calls to or from other countries or regions, roaming SMS, Home Direct Line service and roaming video call services. If usage exceeds the amount included in the service, or if any related service usage is generated on any network, it will be charged at standard roaming rates. 10. The data usage display interface, SMS alerts, and related notifications may differ from actual usage. There may be delays, cancellations, transmission errors, or failures in sending/receiving when applying for free or paid data add-ons. 3HK will not be held responsible for such issues. For actual usage and charges, please refer to the customer's next bill.
11. Upon subscription to the designated World Plan, the Customer may, at the same time, elect to subscribe to Multi-SIM service with an additional secondary SIM card. Maximum 1 add-on secondary SIM are allowed for each subscription. The Local Data and Voice of 5G Multi-SIM Plan (Data + Voice Sharing) are shared by all 5G add-on secondary SIMs. The cumulative usage of the primary SIM card and all secondary SIM cards shall be counted toward the usage allowance of the primary SIM card's plan. Unless specified, all additional VAS subscription including but not limited to roaming services, data top-up service, voice package, content provider services CANNOT be shared between primary & secondary sim.
12. At the end of the contract period, 3HK will charge at the prevailing rate if the customer continues to use the service.
13. Unless otherwise specified, The Offer cannot be used in conjunction with other special promotions or discounts.
14. Prepayment of \$100 per SIM card fee is required for this SIM subscription plan and such prepayment will be refunded to the customer's mobile account for monthly service fee payment after having used The Service for 1 month.
15. In case of early termination of the Service during the contract period for whatsoever reasons,

customer shall have to pay 3HK the designated liquidated damage (the sum of the monthly fee for the remaining unfulfilled contract period) as compensation. All secondary SIMs will be disconnected if the primary SIM service is suspended by whatever reasons.

16. If usage is incurred due to tethering or PTP including applications such as (but not limited to) BitTorrent, edonkey, flashget, foxy, ppstream, winmx, etc, or if there is any abusive or abnormal usage, 3HK shall have the right to forthwith terminate The Service without prior notice. All commercial or illegal promotion activities via the use of The Service shall be prohibited.
17. Usage of The Service is subject to roaming coverage, system compatibility and other relevant conditions of the designated networks, which are subject to change without prior notice.
18. 3HK reserves the rights to amend the charges and terms and conditions (including but not limited to designated destinations and designated networks, their coverage, system compatibility and other relevant conditions of the designated networks) of The Service and to suspend or terminate any part of The Service at any time without prior notice, especially in case where roaming partner terminates cooperation with 3HK. 3HK shall have the final decision in case of any dispute.
19. All service contents and charges are subject to final decision of 3 Hong Kong. 3 Hong Kong reserves the right to change the contents and charges without prior notice.
