



## 免費試用兩個月Uber One會籍優惠 Two-month Uber One membership free trial offer

### 條款及細則：

1. 此優惠期由即日起至 2026 年 7 月 31 日止。視乎供應情況，先到先得。
2. 此優惠僅適用於香港境內。
