



## “Health Check-up Offer”

### General terms and conditions:

1. This Health Check-up Offer (the “**Offer**”) is only applicable to customers who have successfully subscribed to the designated “Health Fit 5G Plan(s)” (the “**Monthly Plan**”).
2. The Offer will be distributed in the form of e-vouchers (the “**e-Vouchers**”) to the customer’s 3 Hong Kong account, according to the schedule below:
  - The 1<sup>st</sup> to 2<sup>nd</sup> e-Vouchers: to be issued 30 days after successful activation of the designated Monthly Plan;
  - The 3<sup>rd</sup> to 4<sup>th</sup> e-Vouchers (if applicable): to be issued 210 days after successful activation of the designated Monthly Plan.
3. On the e-voucher issuance dates stated in Clause 2 above, customers will receive an SMS for e-Voucher collection. Customers must collect the e-Vouchers via the My3 App (the “**3 Hong Kong Platform**”) and proceed to the designated page to redeem the relevant health check-up service within 180 days from the date of the SMS. Late collection will not be accepted. Please refer to the SMS for details.
4. The e-Vouchers are provided by ESD Services Limited (“**ESDlife**”) and are only applicable for redemption of the following designated health check-up services on the health.ESDlife platform:
  - Essential Health Screening e-Voucher: Redeemable for one time of “Swindon Basic Health Checkup B”;
  - Premium Health Screening e-Voucher: Redeemable for one time of “Mobile Medical Detailed Health Checkup”.
5. The validity period of each e-Voucher will be displayed on the relevant page of the 3 Hong Kong Platform. Customers must redeem the designated health check-up service on the specified page of the health.ESDlife platform within the e-Voucher validity period and enter the e-Voucher code before check-out.
6. The e-Vouchers are only applicable to the basic health check-up items included in the designated health check-up services. Any additional check-up items selected by the customer shall be subject to extra charges payable by the customer.
7. Customers must register as a member of the health.ESDlife before redeeming the health check-up services.
8. For service details, terms and conditions of the above health check-ups, please refer to the redemption page of the relevant services.
