



“Free AI Tokens Promotion” – Terms and Conditions

1. Promotion Period and Eligibility

- a. The promotion period runs from **1 July 2026 to 31 August 2026** (both dates inclusive).
- b. During the promotion period, customers who activate (new subscription) a designated 5G monthly plan or complete renewal order confirmation of a designated 5G monthly plan are eligible. The designated 5G monthly plans include SIM plans and 5G broadband services. The offer is not applicable for secondary SIM account.
- c. Each eligible customer account is entitled to redeem the reward once only during the entire promotion period.
- d. The Complimentary AI Tokens are an additional bonus; they are not included as part of the terms of any auto-renewed contract.
